 Need based tuition assistance, representing a meaningful portion of the family tuition responsibility, is awarded to make Lutheran Elementary School education in the St. Louis metro community accessible to children from all faith, ethnic, and economic backgrounds. Roughly 650 students were served with this funding.

 Produced and provided four professional development programs for educators in member schools, delivering nearly 2,300 hours of professional developing programming to roughly 500 educators. Reviewed and updated curriculum guides to meet state and national education standards, to assist individual schools in developing curriculum, provided support to maintain student counseling programs in member schools, and launched a new STEM program which provided instructional resources and teacher training.
